I. Service Requirements/Terms of Reference (ToR)


Background

UNFPA is the United Nations sexual and reproductive health agency. It works in more than 150 countries including China, to ensure every pregnancy is wanted, every childbirth is safe, and every young person's potential is fulfilled.

For UNFPA, achieving universal sexual and reproductive health and rights (SRHR) for all is a priority. At the global level, in 2016, UNFPA launched the WE DECIDE global programme to promote the empowerment and rights of women and young persons with disabilities. In 2018, UNFPA launched a global study "Young Persons with Disabilities: Global Study on Ending Gender-based Violence and Realizing Sexual and Reproductive Health and Rights" and "Guidelines on Providing Rights based and Gender Responsive Services to Address Gender Based Violence and Sexual and Reproductive Health and Rights for Women and Young People with Disabilities". In 2023, UNFPA launched the TOT Curriculum of "Our Bodies, Our Rights! Addressing Sexual and Reproductive Health and Rights and Gender-Based Violence for Women and Young Persons with Disabilities: An In-Person Workshop/A Virtual Workshop Curriculum for Organizations of Persons with Disabilities".

UNFPA has been actively advocating for improving sexual and reproductive health and rights of persons with disabilities (PWDs). From 2020-2021, in partnership with Rehabilitation International and with support from governments, UNFPA conducted a series of activities to strengthen and improve sexual and reproductive health and provision of gender-based violence information and services for women and young people with disabilities both in the Asia-Pacific region and China in support of the full realization of disability inclusive development. UNFPA is committed to continuously advocate for the SRHR of PWDs.

From 2024-2025, UNFPA together with UNESCO and ILO is implementing the United Nations Partnership on the Rights of Persons with Disabilities (UNPRPD) in China in collaboration with the UN Resident Coordinator Office and the Government of China, to ensure the rights of persons with disabilities are fully respected, protected, and fulfilled, and to address issues such as accessibility, education, employment, sexual and reproductive health needs and services.

The Government of China is advancing commitments to promote the rights and interests of persons with disabilities, with a particular focus on their health and overall wellbeing. In 2024, UNFPA partnered with a Chinese organization of persons with disabilities (OPD) to translate and adapt the 'Our Bodies, Our Rights! Addressing Sexual and Reproductive Health and Rights and Gender-Based Violence for Women and Young Persons with Disabilities' curriculum. Using the curriculum, three training workshops were conducted to enhance awareness, knowledge, and access to sexual and reproductive health and rights and gender-based violence (GBV) information and services for women and young individuals with disabilities. To provide women with hearing impairments accessible information on preventing and responding to domestic violence, with UNFPA China support, a OPD developed and launched the 'No More silence' mini-program in Chongqing, offering resources such as violence risk assessments, sign language support, and comprehensive information on anti-domestic violence services nationwide. UNFPA will continue collaborating with government entities and federations of persons with disabilities to implement the UNPRPD project, advancing the health and wellbeing of women and young people with disabilities.

Objectives


- **Development objective(s)**

The overall objective of the assignment is to engage an organization of persons with disabilities (OPD) to conduct a series of activities to promote SRHR for persons with disabilities (PWDs), especially women with disabilities, under the framework of UNPRPD joint project linked to UNFPA mandated areas.

- **Immediate objective(s)**

This series of activities aims to contribute to the following specific objectives:

- The set of TOT Curriculum “Our Bodies, Our Rights! Sexual & Reproductive Health and Rights and Gender-Based Violence for Young People with Disabilities Curriculum” are used for training of OPDs.
- The availability of accessible high-quality, stigma-free sexual and reproductive health (SRH) information for people with disabilities—especially for women and girls—ensuring they benefit from state-of-the-art care.
- The capacity of youth and women with disabilities is enhanced with comprehensive knowledge of their rights to effectively advocate for and engage with service providers, empowering them to effectively advocate for and engage with service providers, and ensuring their access to essential SRH services in line with the Convention on the Rights of Persons with Disabilities (CRPD).
- The access for women and young people with disabilities to essential and more inclusive services to address gender-based violence is improved through the use of technological innovations and thereby strengthening the GBV/SRH service delivery system to align with implementation of the CRPD.
- The dissemination and impact of the UNPRPD project by developing multimedia communication materials, engaging key stakeholders such as local civil affairs bureaus, local federations of persons with disabilities and OPDs, and implementing targeted media campaigns to amplify project outcomes and best practices.

Outputs / Deliverable(s)

Based on the activities to be performed, the organization is expected to deliver the following:

1. A comprehensive bilingual work plan outlining the implementation timeline, key partners, and budget for all activities.
2. A Chinese version of the TOT Curriculum “Our Bodies, Our Rights! Addressing Sexual and Reproductive Health and Rights and Gender-Based Violence for Women and Young Persons with Disabilities” with improved translation and a local training guide with tips as supplementary training material to roll out the TOT training in different cities.
3. A workplan to roll out of TOT training workshops (online or in-person) to work with at least 6 key selected local OPDs with each OPD providing at least two training sessions with the involvement of at least 150 participants from at least 10 underserved regions such as Yunnan, Guizhou, Sichuan, Chongqing, Tibet, Xinjiang, Qinghai, and Gansu among other cities. Special attention will be given to adolescents and young people in underserved rural areas and those enrolled in special education schools.
4. A progress report on the roll out of TOT training workshops (online or in-person), detailing participants demographics (age, disability types, female or male, geographic areas) and documenting follow-up training sessions conducted by partner organizations to extend the participants from at least 10 underserved regions.
5. A progress report on the enhancement of the mini-APP, including improved features (violence risk assessments, sign language support, SRH information, comprehensive anti-domestic violence service information) and the users of the APP expended to at least 15 cities, and information from a dedicated experience-sharing seminar/workshop in a selected city.
6. A progress report on the seminar/workshop on Inclusive SRH Information and Service in a selected city, including details of the seminar organized, participation of local government/foundation representatives, local federations of persons with disabilities, PWDs, and outcomes from discussions, involving a minimum of 50 attendees.

Activities


Activities include but are not necessarily limited to the following tasks:

1. Roll out TOT Curriculum through recruiting at least 6 key local OPDs to conduct TOT workshops with the involvement of at least 150 participants. Among these participants, at least 80% will be persons with disabilities (PWDs), with the following breakdown: 80% will have either visual impairments, physical impairments, hearing impairments, or speech impairments; 60% of the participants will be female; 50% from rural or underdeveloped areas.

To extend the training's reach, one recruited key OPD can disseminate knowledge focusing on underserved regions, including provinces such as Yunnan, Guizhou, Sichuan, Chongqing, Tibet, Xinjiang, Qinghai, and Gansu. Each participating organization will conduct at least 2 training sessions (online or offline) during the project period, accompanied by comprehensive training reports, summarizing the training outcomes, participant feedback, and recommendations for future initiatives.

In consultation and collaboration with local governments and federations of person with disabilities, special attention will be given to adolescents and young people in underserved rural areas and those enrolled in special education schools, who often face compounded barriers in accessing accurate, age-appropriate, and inclusive information, to increase their awareness, knowledge, and skills to make informed decisions, communicate effectively, build healthy relationships, and advance their health and wellbeing.

2. Further test and improve the innovative mini-program by adding resources such as sign language support, and comprehensive information on anti-domestic violence services, expanding the users of the APP to at least 15 cities. Organize at least 1 advocacy event (online, in person or hybrid) in a selected city to increase awareness and usage of the mini-program among the target audience and host a seminar in the selected city for users and stakeholders such as local federations of persons with disabilities and local women's federations to share experiences, provide feedback, and discuss scale-up of the mini-program.
3. Conduct a seminar/workshop in a selected city themed around Inclusive SRH Information and Service to commemorate Beijing+ 30, cooperating with at least 1 local foundation/government entity, local Disabled Persons Federation, and inviting product designers and local government representatives and PWDs. The seminar will include discussions, and collaborative sessions with a minimum of 50 attendees, focusing on enhancing accessible SRH services for women and young persons with disabilities.
4. Document successful experiences and lessons learnt around TOT training and the use of innovative mini-app for PWDs to showcase the achievements and impact of the UNPRPD project over the past two years and produce good practice briefs/ as promotional brochures in both Chinese and English, printing at least 50 copies of each version for distribution at relevant events and to stakeholders.
5. Produce a set of at least 30 professional photography photos with descriptions of photos to document the activities.

- Proven experience of successful mini-program development.
- Experience of working with the UN agencies on relevant health projects especially sexual and reproductive health of PWDs.
- Well understanding of local ethnic culture/norms about SRH and GBV and being gender sensitive among PWDs.
- Proven experience to deliver high quality products on time.
- Knowledge of international development and UN functions in China.
