The duty station of the national UN Volunteer is located in Beijing city, where adequate public infrastructure and health services are available. It is the foremost political and cultural metropolis in China. The city has excellent health services available.

In general, rent for apartments in central locations is high relative to other regions in China, but quality is good. Beijing is well served by many shopping malls, large supermarket chains and international brands. Buses and subways are the most common form of mass transportation. Metered taxis are widely available and domestic and regional travel by train and airplane is popular.

The National UN Volunteer receives a standard volunteer living allowance (VLA), which is intended to cover their accommodation and basic living expenses. In China the VLA is 8,167 RMB per month. The

Organizational Context/Project:

UNFPA is the United Nations sexual and reproductive health agency. Our mission is to deliver a world where every pregnancy is wanted, every childbirth is safe and every young person's potential is fulfilled. UNFPA's goal is to achieve universal access to sexual and reproductive health, realize reproductive rights, and reduce maternal mortality to accelerate progress on the ICPD agenda, to improve the lives of adolescents and youth, and women, enabled by population dynamics, human rights, and gender equality. Sexual and Reproductive Health Unit is a programme unit in UNFPA China. It focuses on leveraging national and international expertise and technical assistance to support China's efforts on promoting Sexual and Reproductive Health (SRH).

China Family Planning Association (CFPA), founded on May 29,1980, is the largest non-governmental network in China active in reproductive health, family planning and HIV/AIDS prevention and care. CFPA's mission is to act as a channel for external resources and expertise while taking a role in public mobilization and education for population and health programs. CFPA plays an important role in providing information and education and promoting voluntary family planning in China. CFPA provides people with family planning, maternal and child health, healthier childbearing and adolescent sexual and reproductive health, both information and services. The CFPA's main target groups are the vulnerable ones such as women of reproductive age in economically less developed areas, young people, migrants and ethnic minorities in remote areas.

Brief Portfolio Description:

"Improving Sexual and Reproductive Health among Vulnerable Populations in Qinghai and Shanxi Provinces in China, 2019- 2021" is one of the projects on Sexual and Reproductive Health under the cooperation between UNPFA, CFPA and National Health Commission of the People's Republic of China. Output 2: Improved availability of rights based, gender sensitive and integrated sexual and reproductive health information and services for women and young people from vulnerable population including ethnic minorities in the four selected project counties.

Output 3: Improved skills, knowledge and positive towards sexual and reproductive health and rights among young people in the selected project counties.

Under the guidance of the Director of Department of International Cooperation of CFPA, and direct supervision of UNFPA SRH Programme Specialist and Youth Analyst, the UNV will assist in the coordination and management of the above mentioned project including planning, monitoring and reporting of the project in Qinghai and Shanxi provinces, and she/he will also provide support for local implementation of the project and coordination among UNFPA, CFPA, MCH and local partners. The job involves maintaining constructive relationships with the Government, civil society organizations, other UN agencies, donors and the private sector.

The UN Volunteer will be placed at the office of CFPA and regularly report back to UNFPA.
